1. Psychiatry

ELIGIBILITY: Residency Training Program

1. Candidate must possess MBBS or equivalent degree registered by PMC.
2. Must possess one year house job from a PMC recognized institution.
3. Permanent valid registration with PMC.
4. **Declared successful in Part-I**
5. In case of foreign candidate, valid registration with Medical Council of their country of origin must be produced.


REQUIREMENTS

GENERAL INFORMATION

1. Selection of candidates will be made strictly on open merit basis.

2. Candidates who are Government Servants / Serving in Autonomous bodies and regular Medical Officers of PIMS should apply through proper channel with NOC. EOL will be required from parent department to join the courses if selected.
3. Selection of candidate will be final on approved criteria/academics/interview.
4. Top Five (5) candidate will be called for interview for one post.
5. No TA/DA will be paid for interview. Incomplete application forms shall not be entertained.
6. **Candidates who are already under training in other Institutions and Registered with CPSP/university are not eligible to apply.**
7. Last date for submissions of applications forms is 05-08-2022 till 04:00 PM

9. In case of incorrect information, the selection committee has the right to cancel the application for admission without any fee refund.
